- All models have shelf fronts of clear, solid maple (unfinished).
- Wine racks and beverage shelves may be fully extended at 90° door opening.
- Shipping weight: 125 pounds.

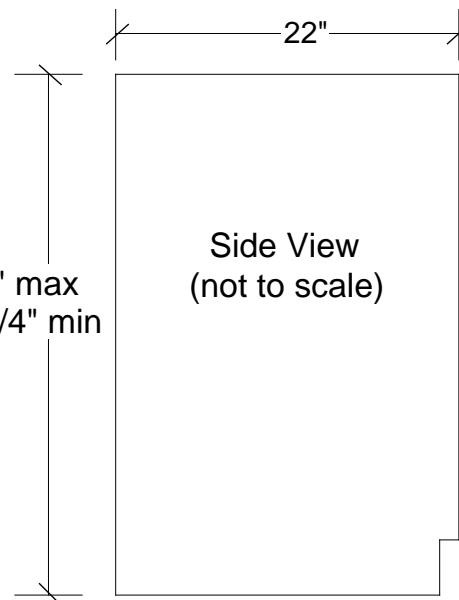
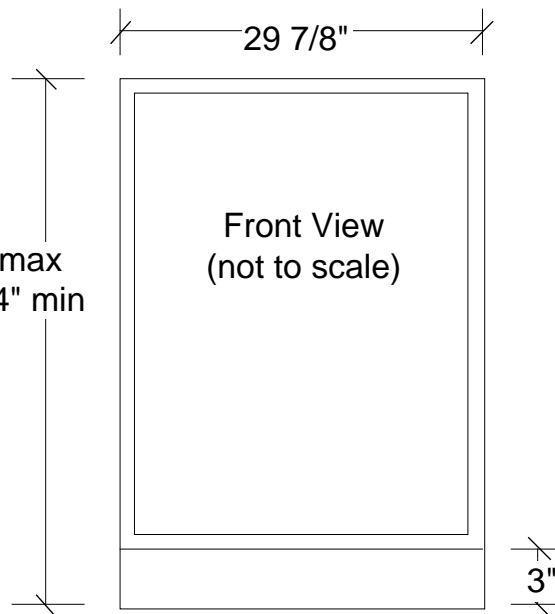

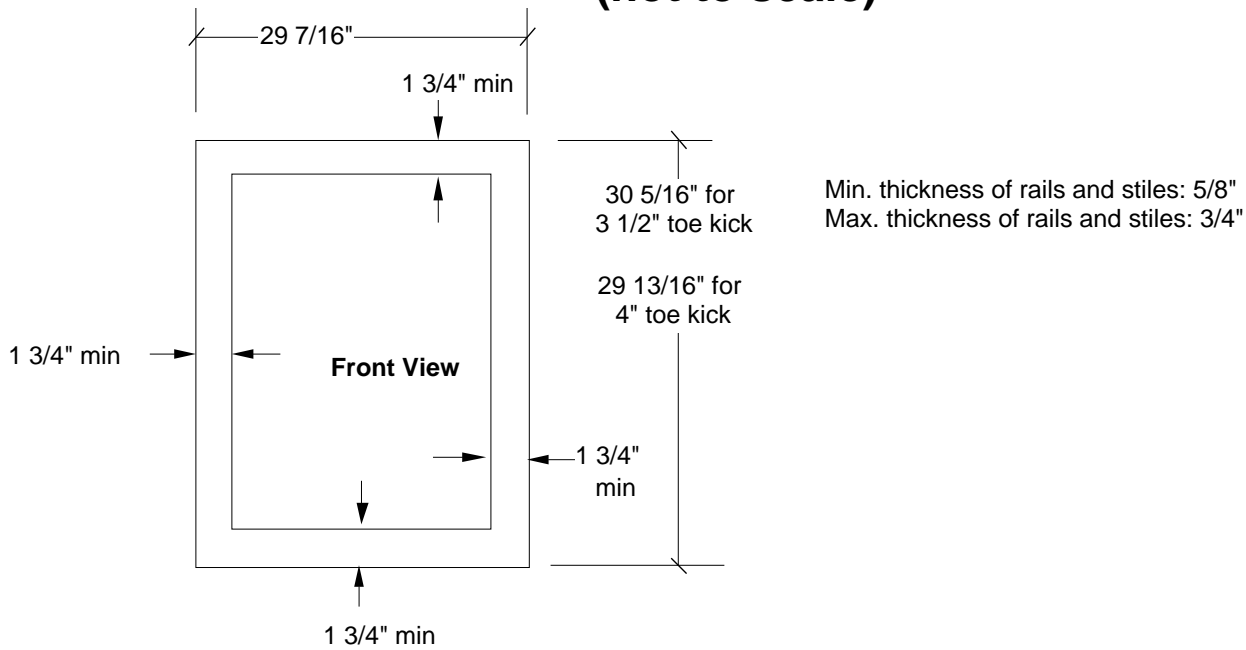
